*Note: By New Mexico Law, Certified ADSs may only practice within a board-approved substance use treatment, prevention or harm reduction program with supervision by a NM licensed Doctor of Oriental Medicine at least every 6 weeks the first year of certification. Certified ADSs must have a GED and not have been convicted of a crime within the past two years.*

**Supervised internship** of 40 clients. In order to be NM Certified or get a NADA certificate of completion, you will need to complete the supervised internship. You are responsible for identifying your supervisor. We are happy to provide a list of approved supervisors. You may need to pay your supervisor. Scholarships for Part 1 are available to all NM Integrative Wellness MRC members.
